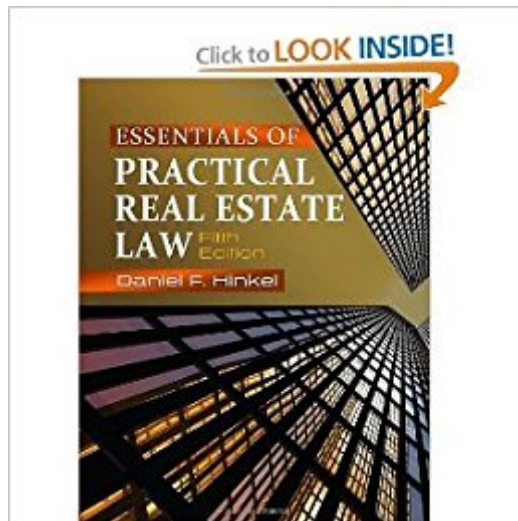

If you want to have both from which the study real estate, you can't go wrong with this book. It covers everything well. The print is small and I would've exchanged a greater wait for the book for slightly larger print. The questions at the end of each chapter are very useful because 1) the true, false are helpful for making sure you know the basic concepts and 2) the questions which involve a written the short answer will test you on how much you understand certain concepts that have greater depth the simple true false.

I rented the Kindle version. This is a great guide for step by step use. Lots of checklists, and very thorough. That is what makes the book so boring. If I was going to close a real property transaction, I would definitely consult this text. Wow... What a snoozer! But, real estate law is not as interesting as say, criminal law.

Nothing wrong with the book, but there are newer editions. caused much consternation in class, my fault for getting an old edition.

I am enrolled in a paralegal certificate program. I read other textbooks, some of which I thought were great and some weren't. I don't think it is written as clearly as other textbooks did, especially when the author tried to explain concepts. Some of his definitions are very vague. Examples of situation help but he sometimes repeat explaining the same situation over, which shouldn't be necessary. He should be able to concisely do it the first time. I think other author may be able to do this job better. The concepts are fairly basic. If you look up the concept in some of the legal

definition sites, they do far better job. Much more articulate. If this is not a required textbook, I would not recommend it to a friend.
